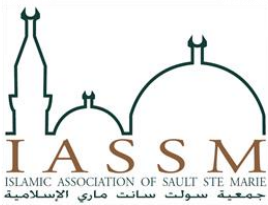

Regular Member:

- a. Must be a Muslim.
- b. Must live within the District of Algoma or Sault Ste. Marie Michigan.
- c. Must have legal status in Canada (student visa, Refugee, Permanent Resident, Canadian citizenship) or in U.S.A.
- d. Must pay annual membership fees as defined by the association.
- e. Must complete and submit a membership form and member is accountable for ensuring form is kept up to date.
- f. Membership is subject to approval and review by the IASSM Board and can be revoked as per article 6 of the by-laws.
- g. Must be at least 18 years of age to be considered a single member.
- h. Must adhere to all the rules set forth by the Association.

Active Member:

- a. Must satisfy all the requirements of regular membership.
- b. Active participation to support the association's activities and events will be required.
- c. Must attend at least one (1) general membership meeting each calendar year (exceptions will be made for illness or other prior obligations if provided in writing.)
- d. May be required to serve as an auditor of the board.

Membership Privileges Include:

- a. Active members will receive one complimentary key fob.
- b. The ability to vote
 - i. Regular or active members are allowed to vote.
- c. Attendance General Membership meetings
- d. Participation in volunteer Activities
- e. The opportunity to raise concerns and issues
- f. Use of the Masjid for events or gatherings, subject to prior approval in writing submitted to the IASSM Board at least seven (7) days in advance.
